1. He is the current Manager and Secretary of 2005 72ND DRIVE EAST, LLC, a Florida limited liability company, whose Articles of Organization were filed with the Department of State, State of Florida, on November 26, 2013.

2. The following Amendment to the Articles of Organization was unanimously adopted by the Members at a special meeting at which all of the Members were present and voting throughout, duly called for the purpose of adopting this Amendment and held on March 20, 2017.

"ARTICLE I - NAME

The name of this Limited Liability Company is:

ARTICLE III - PURPOSES

In the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the continued


membership of a member, the remaining members shall continue the business operations of this Limited Liability Company.
