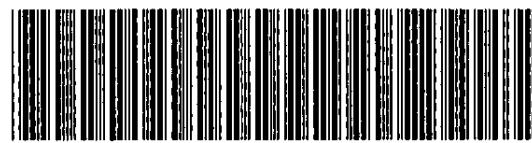

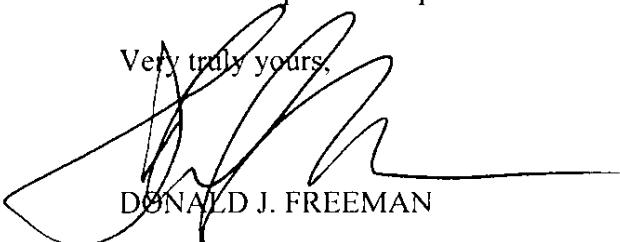

**ARTICLES OF ORGANIZATION  
OF  
FREEMAN GENERAL SERVICES, LLC**

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do so set forth the following:

**ARTICLE I - NAME**

The name of the limited liability company is FREEMAN GENERAL SERVICES, LLC (hereinafter referred to as the "Company").

**ARTICLE II – PERIOD OF DURATION**

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

**ARTICLE III - PURPOSE**

The purpose for which the Company is organized is to engage in any and all business and activities permitted under the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

**ARTICLE IV – ADDRESS OF PLACE OF BUSINESS**

The mailing address for the Company is 533 Palmetto Drive, Lake Park, Florida 33403, and the street address of the place of business for the Company is 533 Palmetto Drive, Lake Park, Florida 33403. These addresses may be changed from time to time as provided in the Operating Agreement.

**ARTICLE V – REGISTERED AGENT**

The initial registered agent in Florida for the Company is Donald J Freeman, Esquire, and the initial registered office is located at Freeman & Jones, LLC, 2475 Mercer Avenue, Suite 301, West Palm Beach, Florida, 33401.

**ARTICLE VI – CAPITAL CONTRIBUTIONS**

Contributions to the capital of the Company shall be made by the members, in the manner prescribed by the written Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

## **ARTICLE VII - MEMBERS**

The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then-existing members, or as otherwise provided in the Operating Agreement.

## **ARTICLE VIII – CONTINUITY OF BUSINESS**

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminated the continued membership of a member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all the remaining members of the Company.

## **ARTICLE IX - MANAGEMENT**

This Company will be managed by one or more managers appointed by the members in accordance with the terms of the Operating Agreement. As such, the Company will be manager-managed. The managers will be designated as the president, secretary, and treasurer of the Company, and may also be designated as vice presidents, assistant secretaries, and assistant treasurers, and shall have the authority normally associated with these positions under corporate law. The Company may also designate persons as directors under the Operating Agreement who shall act in the manner similar to the directors of a corporation. The members, at a meeting of the members held not less than annually, shall designate the managers, who may be members, and the positions that these managers will hold. The initial managers, who shall serve until the first annual meeting of the members or until their successors are elected and qualified, and their designations shall be as follows:

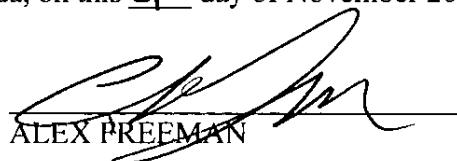

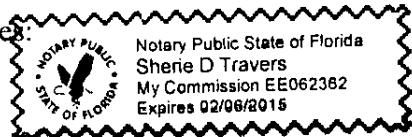

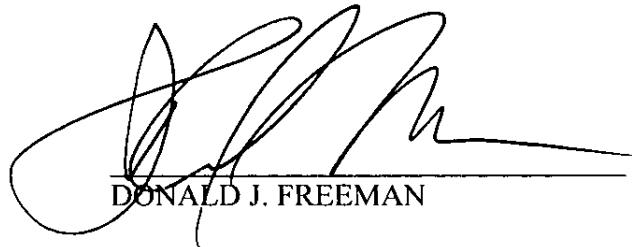
