ARTICLES OF ORGANIZATION OF J JAEGGER INVESTMENTS, LLC

Pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Linkited Linkity Company Act"), the undersigned representative of the members, for the pursues of forming a Florida limited liability company, hereby adopts the following Articles of Organization:

ARTICLE 1 NAME

The name of the company is I JAEGGER INVESTMENTS, LLC. (the "Company").

ARTICLE 2 DURATION AND PLACE OF BUSINESS

The period of duration of the Company is perpetual and its principal place of business is at 555 Northeast 15th Street, Unit 418, Miami, Florida 33132. The Company may also maintain an office or offices at such other place or places, either within or without the State of Florida as may be determined, from time to time, by the Company's manager.

ARTICLE 3 MAILING ADDRESS

ARTICLE 4 PURPOSE

The purposes for which the Company is organized are to engage in any lawful act or activity for which corporations may be organized under the Florida Limited Liability Company Act.

- 6.2. <u>Initial Managers</u>. The name of the Company's initial Manager is <u>Ademir Elester</u>. <u>Serono</u>, an individual, whose mailing address is 407 Lincoln Road PH-NE, Mismi Beach, Florida 33139.

ARTICLE 7 LIMITATION OF LIABILITY OF MANAGERS AND MANAGING MEMBERS

The liability of the managers and managing members of the Company for monetary damages shall be eliminated to the fullest extent permissible under Section 608.4228 of the Florida Limited Liability Company Act.

ARTICLE 8 INDEMNIFICATION OF COMPANY'S AGENTS.

Subject to the applicable limits set forth in Section 608.4229(2) of the Florida Limited Liability Company Act, the Company is authorized to provide indemnification of its members, managers, managing members, officers, employees, and agents through operating agreement provisions.
