Upon the death, bankruptcy, or other dissolution of the Member(s), or the occurrence of any other event that terminates the continued membership of the Member(s) in the Company, the existence of the Company shall continue.

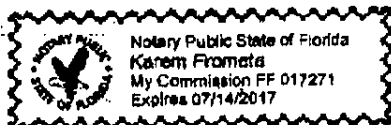

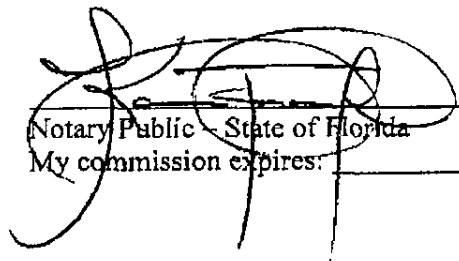
