

ARTICLES OF ORGANIZATION OF FAMILY PET, LLC

The undersigned, in order to form a limited liability company pursuant to the Florida Limited Liability Company Act (Florida Statutes, section 608.401 *et seq.*,) hereby states as follows:

ARTICLE 1
