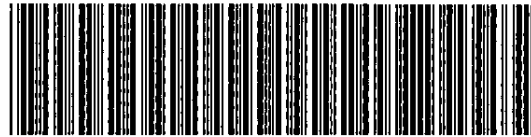

The effective date is November 18, 2013 and the period of duration for the Limited Liability Company shall be perpetual.




