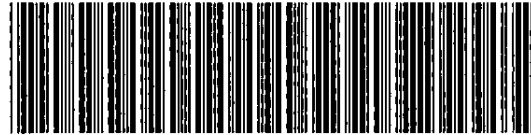

The name of the limited liability company is: ROOT SELECT, LLC.


ARTICLE II. ADDRESS


