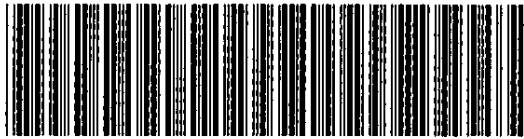

This limited liability company shall have a perpetual existence, unless dissolved according to law, effective as of the 27<sup>th</sup> day of November, 2013.

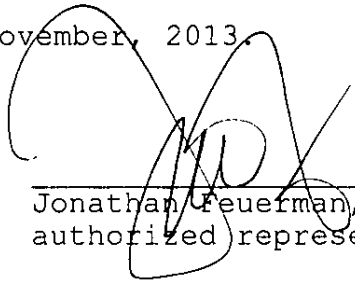

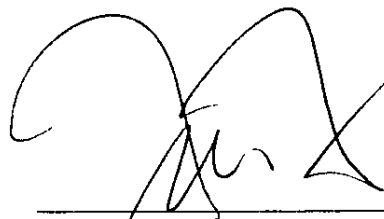
