ARTICLES OF ORGANIZATION
OF
RED EAGLE I, LLC
a Florida Limited Liability Company

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

ARTICLE I. NAME OF LIMITED LIABILITY COMPANY

The name is: RED EAGLE I, LLC, a Florida Limited Liability Company, (the "Limited Liability Company").

ARTICLE II. ADDRESS

ARTICLE III. REGISTERED AGENT

ARTICLE V. DURATION.

The existence of the Limited Liability Company shall be perpetual, unless terminated by written agreement of the members, or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any event which terminates the continued membership of a member, unless the existence and business of the company is continued by the consent and agreement of the remaining member(s) owning a majority of the membership in RED EAGLE I, LLC, a Florida Limited Liability Company or by amendment of these Articles of Organization by providing for the continued existence of the Limited Liability Company subsequent to the foregoing events.

ARTICLE VI. PURPOSE.

ARTICLE XI. OPERATION AND VOTING POWER

In the event of a dispute between Members, final determination shall be made with a vote by the Members. Voting power hereunder shall be exercised based on the percentage ownership interests of the Members. All decisions or determinations of the Limited Liability Company shall be made in accordance with the wishes of the holders of the majority ownership interest in the Limited Liability Company.

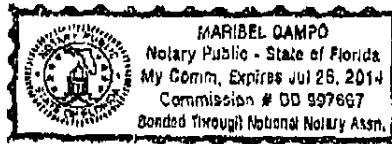


