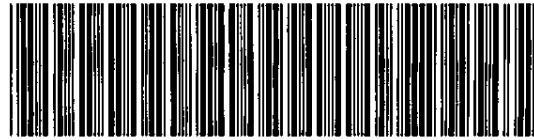




1. The name of the limited liability company is "**ARROYOHOUSE, L.L.C., A FLORIDA LIMITED LIABILITY COMPANY**".
