ARTICLES OF ORGANIZATION

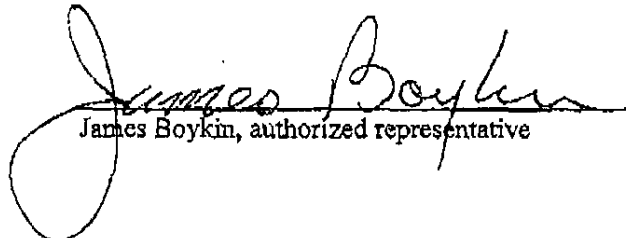
ARTICLE V

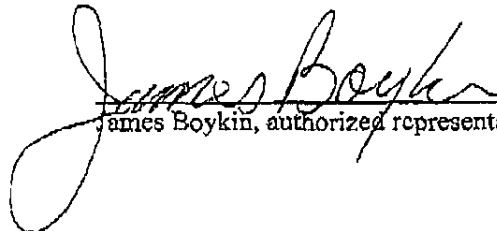

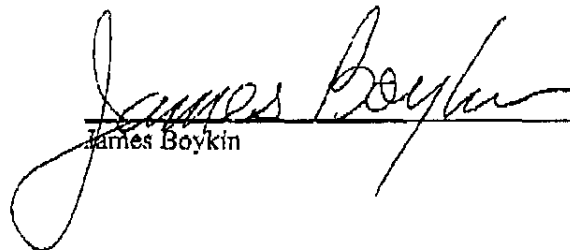
**CERTIFICATE DESIGNATING
