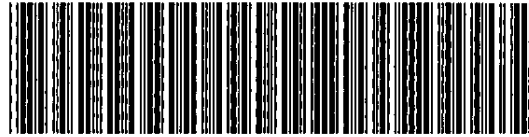

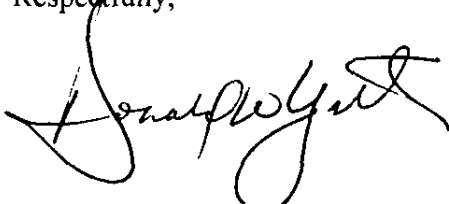

**ARTICLES OF ORGANIZATION OF  
THAT SPECIAL DAY EVENTS, LLC**

**ARTICLE I - NAME**

**THE NAME OF THIS** Limited Liability Company shall be **THAT SPECIAL DAY EVENTS, LLC,**

**ARTICLE II - ADDRESS**

**THE MAILING ADDRESS** and street address of the principal office of the Limited Liability Company shall be 4563 Parnell Dr, Sarasota, Florida 34232.

**ARTICLE III - DURATION**

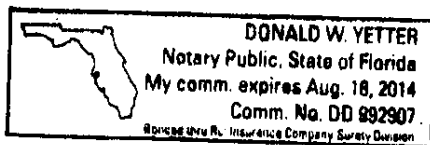
