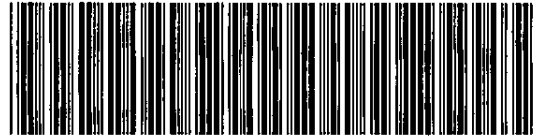



PORTUS MIA GROUP, LLC


**B. REGISTERED AGENT.** The Company's Registered Agent shall remain the same.
