The undersigned, MARY P. STUDER, a natural person competent to contract and a member of MARITIME INVESTOR, LLC, hereby presents these Articles of Organization as the Articles of Organization of MARITIME INVESTOR, LLC, a limited liability company formed under the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:

This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS


