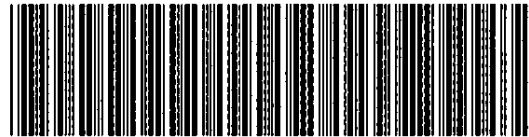

ARTICLE V - Management: The Company shall be managed by members.


