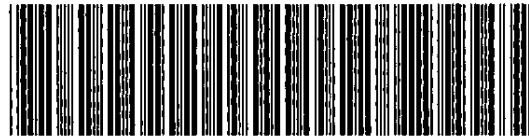

ARTICLE VII - MANAGEMENT

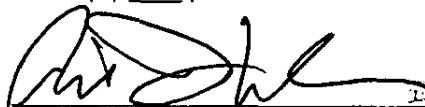

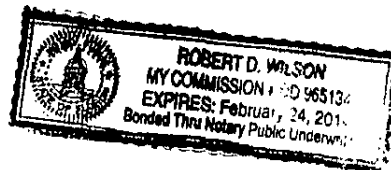

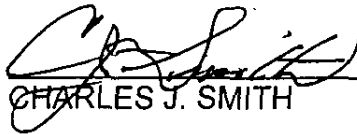
