# ARTICLES OF ORGANIZATION OF RING CENTER, LLC

The undersigned, who intends to form and create a Limited Liability Company, as defined in Chapter 608 of the Florida Statutes, does hereby state and certify the following:

- 1. Name. The name of the Limited Liability Company shall be RING CENTER, LLC.
- 2. <u>Duration of Company</u>. The company shall have perpetual duration.
- 3. Principal Office. The mailing address and street address of the principal office of the Limited Liability Company is 500 World Commerce Parkway, St. Augustine, Florida 32092.
- 4. Registered Agent and Office. The name and street address of the Limited Liability Company's initial registered agent are Randal L. Ringhaver, 500 World Commerce Farkway, St. Augustine, Florida 32092.
