

### ARTICLES OF ORGANIZATION OF

### TAVA INTERNATIONAL A LIMITED LIABILITY COMPANY

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S, Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

### ARTICLE I NAME

## ARTICLE VI - PURPOSE AND POWERS
