ARTICLE VI

Purpose:

to advise, coordinate, consult and sponsor funding distributions to daycare and after school centers in the State of Florida under the State Meal Reimbursement Plan.

ARTICLE VII

Said Company is organized exclusively for charitable purposes, including making of distributions to organizations that qualify as exempt corporations under Section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the Company shall enure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Company shall be authorized and empowered to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of the purpose set forth in the foregoing paragraphs hereof. No substantial part of the activities of the Company shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Company shall not participate in nor intervene in any political campaign on behalf or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Company shall not carry on any other activities not permitted to be carried on any (a) by a Company exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code, or (b) by a Company, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Upon dissolution of the Company, assets shall be distributed for one or more exempt purposes with the meaning of Section 501(c)(3) of the Internal Revenue Code, or shall be distributed to the Federal Government, or to a State or Local Government for a public purpose. Any such assets not so distributed of shall be disposed of by a Court of Competent Jurisdiction in the County of which the principal office of the Company is then located, exclusively for purposes or to such organizations as the Court shall determine.
