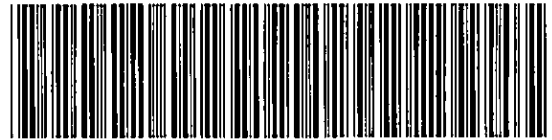

ARTICLES OF ORGANIZATION 21 11 9:21

The undersigned, Brent F. Bradley, a natural person licensed to practice law in Florida and the sole member of Brent F. Bradley, PLLC, which is a member of this professional limited liability company, hereby presents these Amended and Restated Articles of Organization for a professional limited liability company under the provisions of Chapter 621, Florida Statutes.

ARTICLE I - Name

The present name of the professional limited liability company (hereinafter the "Professional Limited Liability Company") is: Walborsky & Bradley, PLLC. The new name of the Professional Limited Liability Company, to be effective upon the filing of these Amended and Restated Articles, is: Walborsky, Bradley & Fleming, PLLC.

ARTICLE II - Date of Filing of Articles of Organization

The date of filing of the Professional Limited Liability Company's articles of organization was December 12, 2013.

ARTICLE III - Address

The mailing address and the street address of the principal office of the Professional Limited Liability Company are: 438 East Government Street, Pensacola, Florida 32502.

ARTICLE IV - Purpose and Powers

The Professional Limited Liability Company is organized for the purpose of providing professional legal services for any legal and lawful purpose for which a professional limited liability company may be organized and may exercise all powers and rights which a professional limited liability company may exercise under the Professional Service Corporation and Limited Liability Company Act.

ARTICLE V - Members

Individual members must be licensed to practice law in the

State of Florida. The shareholders of any member that is a professional service corporation and the members of any member that is a professional limited liability company must each be licensed to practice law in the State of Florida. Contributions required of new members shall be determined as of the time of admission to the Professional Limited Liability Company in accordance with its Operating Agreement.

A member's interest in the Professional Limited Liability Company may not be sold or otherwise transferred except to a person licensed to practice law in the State of Florida, or to a professional service corporation whose shareholders are each licensed to practice law in the State of Florida, or to a professional limited liability company whose members are each licensed to practice law in the State of Florida (or whose members are entities whose shareholders or members, as the case may be, are each licensed to practice law in the State of Florida), in accordance with the Operating Agreement of the Professional Limited Liability Company.

ARTICLE VI - Duration

The period of duration of the Professional Limited Liability Company shall be perpetual.

ARTICLE VII - Management

The Professional Limited Liability Company is to be managed by its members. The names and addresses of the present members of the Professional Limited Liability Company are:

ARTICLE IX - Effective Date


These Amended and Restated Articles of Organization shall be effective the time and date these Amended and Restated Articles of Organization are filed with the Florida Secretary of State.
