

ARTICLES OF ORGANIZATION OF EZEKIEL'S CAFÉ LLC

The undersigned, being an authorized representative of the sole prospective member of EZEKIEL'S CAFÉ LLC (the "Company") to form the Company by executing and filing its articles of organization with the State of Florida, hereby certifies that:

ARTICLE I — Name: The name of the Company is: EZEKIEL'S CAFÉ LLC

ARTICLE II — Address: The mailing address and street address of the principal office of the Limited Liability Company is: 3500 45th Street, Suite 16A, West Palm Beach, FL 33407

ARTICLE III — **Purpose:** The purposes for which this Company is formed are: (i) to provide quality food, including from sources that are in danger of waste, for people in need of better nutrition, (ii) to provide education in nutrition, food preparation, restaurant management and hospitality, as well as (iii) to operate exclusively in any other manner for such charitable, religious, educational and scientific purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended.

ARTICLE IV — **Registered Agent and Registered Office:** The name and the Florida street address of the initial registered agent are: HYMANS, BARBARA, 3500 45th Street, Suite 16A, West Palm Beach, FL 33407

ARTICLE V — **Member(s) & Management:** The sole member of the Company is a Florida Not-For-Profit Corporation and is an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended: WHOLENESS HOUSE INC. The Company shall be manager-managed and the initial manager is BARBARA HYMANS.

ARTICLE VI — Earnings & Activities of the Company:

- (A) No part of the net earnings of the Company shall inure to the benefit of, or be distributable to its managers, directors, officers or other private persons, except that the Company shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes as set forth in Article III hereof.
- (B) No substantial part of the activities of the Company shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Company shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- (C) Notwithstanding any other provision of these articles, this Company shall not carry on any activities not permitted to be carried on (a) by a Company exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a Company, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
- (D) Notwithstanding any other provision of these articles, this Company shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Company.

ARTICLE VII — **Dedication of Assets:** The property of the Company is irrevocably dedicated to charitable, religious, educational, and scientific purposes, and no part of the net income or assets of the Company shall ever inure to the benefit of any manager or officer, or to the benefit of any private individual except as provided in Article VI.

ARTICLE VIII — Distribution of Assets: Upon dissolution of the Company, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the Company, dispose of all of the assets of the Company exclusively for the purposes of the Company in such manner, or to such organization or organizations organized and operated exclusively for charitable, religious, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Manager(s) shall determine. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the Company is then located, to an exempt organization described in this paragraph.

(In accordance with section 605.0201 and 605.0203, Florida Statutes, the execution of this certificate constitutes an affirmation under the penalties of perjury that the facts stated herein are true.)
