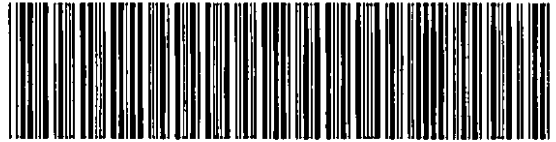




WHEREAS, CREDIBLE LEARNING, LLC is a Florida limited liability company (hereinafter, "Company"); and
