**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
ST. WALDEN LAKE PARTNERS, LLC**

The undersigned person, acting as an authorized representative of ST. WALDEN LAKE PARTNERS, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Amended and Restated Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company commenced on December 16, 2013 and the existence of the company is perpetual.


ARTICLE VII - MANAGEMENT BY MANAGER


ACCEPTANCE OF REGISTERED AGENT
