ARTICLES OF ORGANIZATION OF JBS FLORIDA, LLC

a Limited Liebility Company organized under the laws of the State of Florida

The Undersigned, acting as organizer for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Fla. Stat. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization;

ARTICLE I.

NAME

The name of the limited liability company shall be JBS FLORIDA, LLC., a Florida limited liability company (the "Company").

ARTICLE IL ADDRESS
