

ARTICLES OF ORGANIZATION OF H² PHILADELPHIA RESTAURANT PARTNERS, LLC



- 1. <u>Name.</u> The name of this limited liability company is H² PHICADELPHIA RESTAURANT PARTNERS, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. <u>Duration.</u> The Company shall exist effective as of December 16, 2013 and the Company's existence shall be perpetual.
- 3. <u>Purpose.</u> The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
