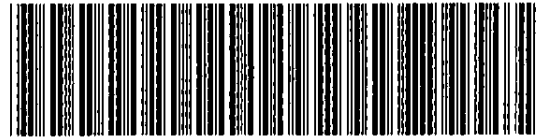

**ARTICLES OF ORGANIZATION
OF
COMSAT NETWORKS, LLC,
A Florida Limited Liability Company**

**ARTICLE I
Name**

The name of the limited liability company ("Company") is COMSAT NETWORKS, LLC.

**ARTICLE II
Address**

The initial mailing and initial street address of the Company's principal office is 7512 Dr. Phillips Boulevard, Suite 50 #114, Orlando, Florida 32819.

**ARTICLE III
Duration**

The Company shall have a perpetual existence, unless dissolved upon the written consent of all of its members or on the occurrence of the death, bankruptcy, resignation, or expulsion of the last one of its members. Management**

ARTICLE VI
Admission of New Members

Member(s) of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.


ARTICLE VII
Continuation of Company

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. ARTICLE VIII
Additional Provisions


