The undersigned hereby forms a limited liability company with the meaning of the applicable provision of Chapter 608, Florida Statutes.

ARTICLE I
NAME

The name of this limited liability company is CELLPHONE MD, LLC (the "Company").

ARTICLE II
DURATION

The Company shall exist commencing on January 2, 2014 the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.




