ARTICLES OF ORGANIZATION  
OF  
LOWELL HOLDINGS OF PENSACOLA, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I  
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is LOWELL HOLDINGS OF PENSACOLA, LLC.

ARTICLE II  
ADDRESS

The Company's street address of its principal place of business in Florida is 1920 E. DeSoto Street, Pensacola, Florida 35201, and its mailing address is P.O. AMENDMENT TO ARTICLES






