**ARTICLES OF ORGANIZATION  
OF  
SWFE MERGERSUB, LLC**

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the limited liability company is SWFE MERGERSUB, LLC (the "Company").

**ARTICLE II  
ADDRESS**

The principal and mailing address of the Company is 450 NW 37 Avenue, Miami, Florida 3312.

**ARTICLE III  
REGISTERED AGENT AND OFFICE**
