
**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION OF
NSC 17 JACKSONVILLE RD LLC**

Pursuant to the provisions of Sections 605.0202, Florida Statutes, the Florida limited liability company adopts the following:

1. The Articles of Organization ("Original Articles") of NSC 17 Jacksonville Rd LLC, a Florida limited liability company ("Company"), were filed on December 26, 2013, and assigned document number L13000177130.
2. The Original Articles are hereby amended as follows:
 - a. Article IV of the Original Articles, is hereby amended to read as follows: The Company is to be managed by one or more managers and is therefore a manager-managed limited liability company. The current managers of Company are as follows: Shirley B. Rudniansyn, 2441 NE 3rd Street, Suite 201, Ocala, FL 34470, and Todd Rudniansyn, 2441 NE 3rd Street, Suite 201, Ocala, FL 34470.
 - b. A new Article V is added to the Original Articles to read as follows: These Articles of Amendment may be amended by the affirmative vote or written consent of a majority of the membership interests in Company.
3. The Amendment set forth herein was approved by the holders of all of the membership interests of the Company. The number of votes cast for the Amendment was sufficient for approval.
