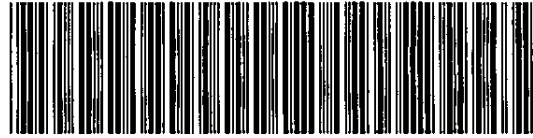

SECOND: This Amendment is submitted to amend the following:


