Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, Dalcour Ridge Club GP, LLC, a Florida limited liability company (the "Company"), whose Articles of Organization were filed with the Florida Department of State on December 30, 2013 under Document No. L13000178104 adopts the following articles of amendment to its Articles of Organization.

The following Article VI is hereby added to the Company's Articles of Organization:

ARTICLE VI  
PURPOSE

The sole purposes of the Company are to be admitted to and to serve as the general partner of Dalcour Ridge Club, Ltd., a Florida limited partnership (the "Owner"), and in connection therewith, to own, hold, sell, dispose of or otherwise deal with its general partnership interest in the Owner. The Company may engage in any lawful act or activity and exercise any power permitted to be performed by the Company under and pursuant to the laws of the State of Florida that is related or incidental to and necessary, convenient or advisable for the accomplishment of the foregoing purposes.

These Articles of Amendment shall be effective at the time of its filing with the Florida Department of State.
