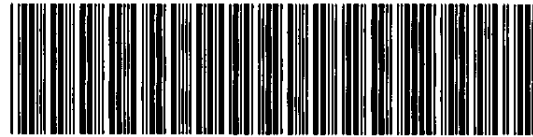

ARTICLE II: Address.

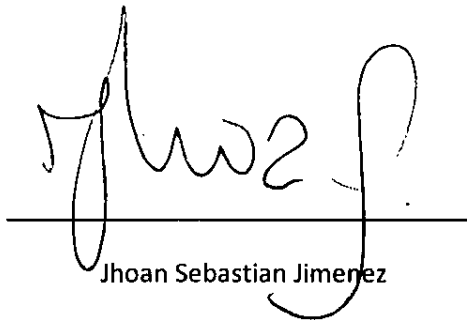

ARTICLE V: Effective Date.

The existence of "Goldem Venture Group, LLC" will become effective on January 1st, 2014.

ARTICLE VI: Management of the Company.

All business affairs decisions related to "Goldem Venture Group, LLC" will be unanimously taken by all managing members together. Therefore, all binding contracts, employment agreements, or any other legal obligation assumed by "Goldem Venture Group, LLC" will require the signature of all three members in order to be valid.

ARTICLE VII: Distribution of Cash & Proceeds, and Tax Allocations.

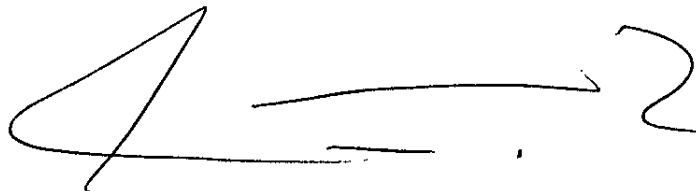
"Goldem Venture Group, LLC" will distribute its net available cash flow among its three members in equal portions. That is: 33,34% for Jhoan Sebastian Jimenez, 33.33% for Julian Borrero, and 33.33% for Carlos Cervantes. In addition, taxes will be allocated in the same way.

ARTICLE VIII: Cessation of Membership.

Voluntary: A member of "Goldem Venture Group, LLC" can withdraw from the company upon unanimous approval of all members. This member shall be entitled to receive the amount of his original investment in the company plus any accumulated profit pending of distribution. Other additional entitlements can only be awarded upon approval of all the managing members of the company.

Involuntary Withdrawal: Upon occurrence of any involuntary withdrawal of a member of "Goldem Venture Group, LLC", the successor or legal representative of such member will not become a managing member, but shall become an interest holder entitled to the economic rights of the original member.
