## ARTICLES OF MERGER

Pursuant to the provisions of Florida Statutes Section 605.1025 and the Florida Revised Limited Liability Company Act, the undersigned parties submit these Articles of Merger.

1. The name of the limited liability company that will survive the merger is EL PASO 1, LLC (the "Surviving Company"). The Surviving Company is organized under the laws of the State of Florida. The Surviving Company's initial Articles of Organization were duly filed with the Florida Department of State on January 3, 2014, Document No.: L14000000815. The Surviving Company's principal place of business is: 2637 E. Atlantic Blvd., #23775, Pompano Beach, Florida 33062.

2. The following organization is a party to the merger and will not survive the merger: ALASKA 1, LLC (the "Merging Company #1"). The Merging Company #1 is a limited liability company organized under the laws of the State of Florida. The Merging Company #1's initial Articles of Organization were duly filed with the Florida Department of State on March 10, 2011, Document No.: L11000029807. The Merging Company #1's principal place of business is: 2637 E. Atlantic Blvd., #23775, Pompano Beach, Florida 33062.

3. The following organization is a party to the merger and will not survive the merger: BOSTON 1, LLC (the "Merging Company #2"). The Merging Company #2 is a limited liability company organized under the laws of the State of Florida. The Merging Company #2's initial Articles of Organization were duly filed with the Florida Department of State on May 17, 2012, Document No.: L12000066896. The Merging Company #2's principal place of business is: 2637 E. Atlantic Blvd., #23775, Pompano Beach, Florida 33062.

4. This merger is approved by each of Surviving Company, Merging Company #1, and Merging Company #2 in accordance with the provisions of Florida Statutes Sections 605.1021 through 605.1026 and by each member of each such limited liability company who, as a result of the merger, will have interest holder liability under Florida Statutes Section 605.1023(1)(b) and whose approval is required.

5. The Surviving Company has agreed to pay any members of any limited liability company with appraisal rights the amount to which such members are entitled under the provisions of Florida Statutes Sections 605.1006 and 605.1061 through 605.1072.

6. The merger shall be effective upon the filing of these Articles of Merger.

7. The applicable plan of merger ("Plan of Merger") is on file at the place of business of the Surviving Company as set forth above, and the Surviving Company will provide a copy of the Plan of Merger on request and without cost to any person who holds an interest in a business entity that is a party to the merger. Each business entity that is a party to the merger approved the Plan of Merger in the manner provided by law.

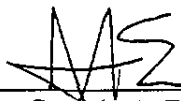

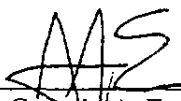
