ARTICLES OF ORGANIZATION OF FAJARDO VALLONE LLC

The undersigned, for the purpose of forming a limited liability company under Chapter 605 of the Florida Statutes (the "Act"), hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME
