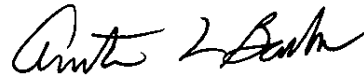

The name of the Florida Limited Liability Company is **Agroflite, LLC.**

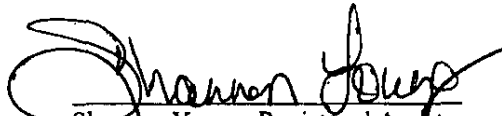
