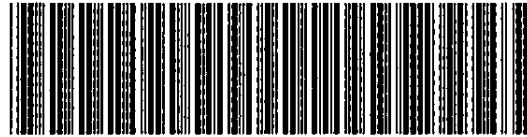



**ARTICLES OF ORGANIZATION  
OF  
SWANSON ASSOCIATES, LLC**

**ARTICLE I - NAME**

The name of the limited liability company shall be SWANSON ASSOCIATES, LLC (the "Company").


