ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be FJ COMPANY LLC ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 3301 Clewiston Street, Deltona, Florida 32738 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

ARTICLE 10 - INDEMNIFICATION

All references in these Articles of Organization to "member", "manager", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons =
