ARTICLES OF ORGANIZATION

FOR

ROYAL DAY CAMPS LLC

The undersigned person, acting as the organizer of a limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 605), hereby adopts the following Articles of Organization:

1. Name. The name of this limited liability company is "ROYAL DAY CAMPS LLC" ("Company").

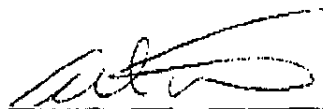
