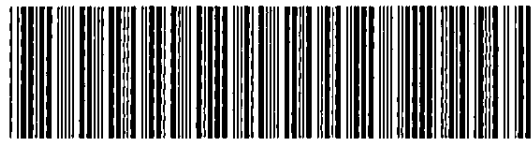

I hereby file these Articles of Organization as the authorized representative of the member of the limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida.

ARTICLE I
NAME

The name of the limited liability company to be formed hereunder is "BB BULLS LLC" (the "Company").

ARTICLE II
DATE OF EXISTENCE AND PERIOD OF DURATION

The Company shall begin existence effective the 6th day of January, 2014, and shall continue until terminated in accordance with the Operating Agreement adopted by its member(s) (the "Operating Agreement").

New members may be admitted to the Company as provided in the Operating Agreement.



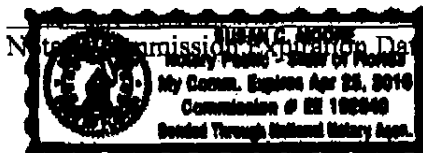


