ARTICLES OF ORGANIZATION

OF

TROY'S SOFFIT AND SIDING L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **TROY'S SOFFIT AND SIDING L.L.C.** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 10707 Indian Drive, Riverview, Florida 33569 and the mailing address shall be the same.

ARTICLE 7 - ADMISSION OF NEW MEMBERS
