AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF CHATEAU 30-A, LLC

The undersigned, Charles W. Rigdon, an authorized representative of a member of CHATEAU 30-A, LLC, a Florida limited liability company (the "Company"), hereby presents these Amended and Restated Articles of Organization pursuant to the provisions of Section 605.0202, Florida Statutes.
