# ARTICLES OF ORGANIZATION OF

## **AML 6355, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company , hereby make, acknowledge, and file the following Articles of Organization.

## **ARTICLE 1 -- NAME**

The name of the limited liability company shall be <u>AML 6355, LLC</u> (the "Company").

## **ARTICLE II -- ADDRESS**

The Company shall be managed by a manager or managers in accordance with the Articles of Organization, the Operating Agreement, the Regulations (if any) adopted by the Members for the management of the business and the ordinary and customary affairs of the Company. The Operating Agreement and/or Regulations, if any, or otherwise the minutes of the Company, shall determine the manner in which such Manager(s) are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the Company that are not inconsistent with the law or these Articles of Organization.
