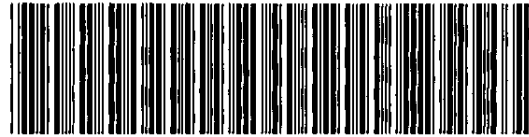

**ARTICLE I**  
**NAME**

The name of this Limited Liability Company is:

**DIVERSIFIED HOBBY PRODUCTS, LLC** (the "Company").

**ARTICLE II**  
**PURPOSE**

A. Purposes. The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Chapter 60~~5~~, Fla. Stat., as the same may be amended from time to time.

AMENDMENT OF ARTICLES OF ORGANIZATION**


These Articles may be amended at any time by a resolution adopted by the members, in conformity with the Operating Agreement permitting said amendment, at any annual or special meeting.


