**ARTICLES OF ORGANIZATION
OF

The undersigned, ANDREW R. FLOCK, a natural person competent to contract and a member of BUFFALO MILL CREEK TIMBER, LLC, hereby presents these Articles of Organization as the Articles of Organization of BUFFALO MILL CREEK TIMBER, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes* (the "Florida Limited Liability Company Act").

ARTICLE I - NAME

The name of the limited liability company is BUFFALO MILL CREEK TIMBER, LLC (referred to in these articles of organization as the "Company").

ARTICLE II - PRINCIPAL OFFICE ADDRESS

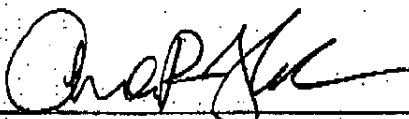
