Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of BLIND PASS, LLC, a Florida limited liability company (the "Company").

ARTICLE 1: NAME AND MAILING ADDRESS

ARTICLE 2: DURATION

This Company shall exist perpetually, commencing on the date of filing.

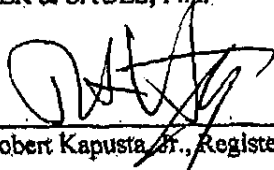
