INDEMNIFICATION**

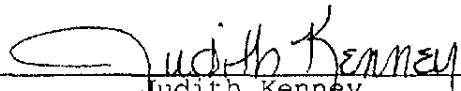

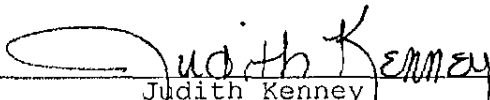
