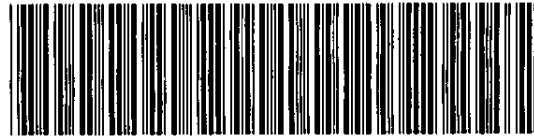

The name of the Florida Limited Liability Company is **Wingfeet, LLC**.


