My family moved to Port Saint Lucie FL in October 2014, I went down to the county clerk's office to get a Handyman License, I was told that they do NOT issue handyman Licenses for anything more than cleaning of gutters, pressure washing cement, and little bogus stuff like that. I told them that I was Licensed in Palm Coast and this is what they said "You want to Sheet Rock you need a License, you want to paint - you need a License, you want to do even minor carpentry you need a License, Each area is a different License, I said "OK is there ~~is~~ a test that I can take for you to License me, they said "Unless you have physically worked for a general Contractor for 4 years or more and they will sign off that you did, then you will not be allowed to do any handyman work and will not be given a License, and you will be fined if you are caught doing handyman work.

So I unwillingly gave up my business and I work solely for a commercial Leasing company under his GC License fixing whatever little things that go wrong.

I requested information from your help line, and over a month later I get the dissolution paperwork which has now taken me out of your 90 day prior window. I stopped my business in Oct 2014
