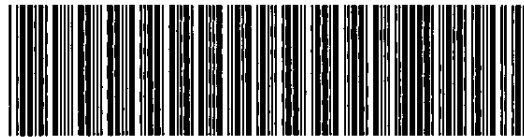

ARTICLES OF ORGANIZATION OF
MORSE TILE AND STONE, LLC

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **MORSE TILE AND STONE, LLC,**

ARTICLE II - ADDRESS

THE MAILING ADDRESS and street address of the principal office of the Limited Liability Company shall be 4813 N Rye Rd, Parrish, Florida 34219.

ARTICLE III - DURATION

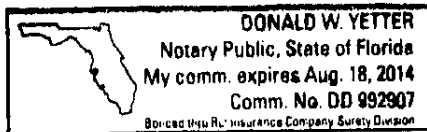
